

INFORMATION ON THE PROCESSING OF PERSONAL DATA

Pursuant to art. 13 of EU Regulation 2016/679 (hereinafter Regulation or "RGPD") and current national legislation on the protection of personal data, this notice is provided to the **natural person who accesses the website of the Data Controller**, hereinafter also **Data Subject**.

2. Type of data processed –

Cookies are short strings of text that are configured and saved by the visited website within the user's browser. The cookie stores information that the website can use when it is browsed. The purpose of cookies is to make navigation of the site more usable, but also the execution of computer authentication, the monitoring of sessions, the storage of information on specific configurations regarding data Subjects accessing the server.

This website uses technical session cookies that are immediately removed from the device of the Data Subject at the end of the browsing session. Consent is not required for these cookies.

This website does not use profiling cookies or third-party cookies, for the latter types of cookies your consent would have been required. [Managing cookies from your browser settings](#). 3. Purpose, legal basis of the processing and obligation to provide data.

The Data Controller uses technical session cookies to check the correct functioning of the website. The provision of personal data for this purpose and its processing are necessary for the operation of the site itself. These processing operations do not require the consent of the data subject. The legal basis of the processing is identified in the legitimate interest of the Data Controller to guarantee the functioning of the site.

4. Categories of recipients of personal data. Personal data, within the limits and with the purposes indicated, may be communicated or become aware of and therefore be processed by:

- A. employees and consultants of the Data Controller, companies that provide IT services (site management, internet services, ...), possibly in their capacity as external Data Processors;
- B. subjects who can access the data by virtue of the provision of law, or community legislation, within the limits established by law.
- C. A detailed list of the recipients of personal data is available from the headquarters of the Data Controller on request.

5. Data retention period. Technical session cookies are deleted at the end of the consultation of the website.

6. Transfer of data abroad. The processing is carried out in the EEA (European Economic Area).

7. Automated decision-making. Automated decision-making and profiling are excluded.

8. Rights of the Data Subject. The Data Controller informs that, with reference to the data provided, you as a Data Subject have the following rights:

- A. access to data and acquisition of a copy (Art. 15 GDPR);
- B. rectification of data: if they are inaccurate by providing adequate documentation;
- C. erasure of personal data: if one of the reasons provided for by art. 17 of the GDPR;
- D. limitation of processing: if one of the hypotheses provided for by art. 18 of the GDPR;
- E. the portability of electronic data that are subject to automated processing;
- F. to lodge a complaint with the competent supervisory authority: Authority for the Protection of Personal Data.
